

Sri B.Ram Babu filed O.A.No.476 of 2018 before the Hon'ble Administrative Tribunal questioning the action of the 3rd Respondent (i.e APPSC) in not selecting him as Lecturer in English against B.C.A(G) category and seeking directions to prepare Selection Notification dated: 27.02.2018 a fresh for the post of reserved for B.C.A(G) and (OC)(G) in English considering his merit.

In reference read 4th read above the Hon'ble Tribunal on 14.03.2018 directed that selections, if any, finalised to the post of Lecturer in English under B.C.A(W) Category shall not be further acted upon by the Unit Officers concerned.

In the 5th read above the Hon'ble Administrative Tribunal in its Orders dated: 16.08.2018 in O.A.Nos. 475 of 2018 and Batch of 7 Other O.As., directed that Unit Officers are at liberty to proceed with the selections that are made by the Service Commission and the Unit Officers shall make it clear in the appointment orders that the appointments to the vacancies reserved will be subject to further orders in these OAs.

In view of the Hon'ble Tribunal Orders dated: 16.08.2018 and Under Rule 10 (a) of the Andhra Pradesh State and Subordinate Service Rules, 1996, **Sri. Chakali Chandra Sekhar** provisionally selected candidate belong to B.C.A.
